

# 负责任矿产承诺书

## 负责任矿产政策

作为全球公民，町洋机电（中国）有限公司 不支持、不使用来自受冲突影响和高风险地区（CAHRA）的金（Au）、钽（Ta）、钨（W）、钴（Co）和锡（Sn）等稀有金属，同时要求我们的供应链：

- 1) 以社会和环境责任的方式开展业务；
- 2) 不使用源自受冲突影响和高风险地区的冲突矿产；
- 3) 向其上游供应商提出相同的要求。

负责任矿产 (Responsible Minerals Initiative): 受冲突影响和高风险地区（CAHRA）的金（Au）、钽（Ta）、钨（W）、钴（Co）和锡（Sn）等稀有金属开采已造成严重的人权与环境问题；这类地区的大部分采矿活动与冲突的武装组织有关（资助），这类地区的特点往往是大规模侵犯人权、违反国际国内法律等，导致此部分地区长期不稳定，故建立负责任矿产计划（RMI）。

受冲突影响和高风险地区 (CAHRA) 是指：“识别为存在武装冲突、大面积暴力活动或其他存在使人民遭受伤害风险的地区。武装冲突的形式多种多样，如国际冲突或非国际冲突，可能涉及两个或两个以上国家，可能由解放战争、叛乱、内战等构成。高风险地区可能包括政局不稳，或存在政治压迫、制度缺陷、不安全因素、民用基础设施崩溃、大面积暴力活动的地区。

受冲突影响和高风险地区：国际公认与刚果民主共和国共享边境的国家，共享边境国家如：卢旺达(Rwanda)、乌干达(Uganda)、布隆迪(Burundi)、坦桑尼亚(Tanzania)、肯尼亚(Kenya)、苏丹、赞比亚、安哥拉、中非共和国，查阅网址：

# Commitment of Responsible Minerals

## Responsible Minerals Policy

As a global citizen, Dinkle Electric Machinery (China) Co., Ltd. is committed not to use the minerals of gold (Au), tantalum (Ta), tungsten (W), cobalt (Co) and tin (Sn) which are from mines Conflict-Affected and High-Risk Areas. Meanwhile, Dinkle requires the suppliers to follow as below:

- 1) Develop the business based on social and environmental responsibilities.
- 2) Do not use mineral conflicts from the Conflict-Affected and High-Risk Areas.
- 3) Ensure to propose the same requests to its suppliers.

Responsible Minerals Initiative are defined rare minerals such as gold (Au), tantalum (Ta), tungsten (W), cobalt (Co) and tin (Sn) extracted from the Conflict-Affected and High-Risk Areas. The mining activities mostly controlled by non-governmental and armed group have seriously caused long-term human right and environmental issues in these conflict regions.

Conflict-Affected and High-Risk Areas (CAHRA) are defined "areas identified by the presence of armed conflict, widespread violence or other risks of harm to people. Armed conflict may take a variety of forms, such as a conflict of international or non-international character, which may involve two or more states, or may consist of wars of liberation, or insurgencies, civil wars, etc. High-risk areas may include areas of political instability or repression, institutional weakness, insecurity, collapse of civil infrastructure and widespread violence. Such areas are often characterised by widespread human right abuses and violations of national or international law.

Adjoining countries of conflict minerals to DRC are international recognized as Rwanda, Uganda, Burundi, Tanzania, Kenya, Sudan, Zambia, Angola and Central African Republic.
